

Important Information Regarding Tax Payments

The town, village and county treasurers mail the real estate tax bills in December. If you do not receive your tax bill by December 30th, please verify your mailing address with your town, village or county treasurer.

Real Estate Tax Payment Options:

1. Pay the **entire bill in full to the Town, Village or County by January 31st: OR**
2. Pay the **first installment to the Town, Village or County by January 31st** and the **second installment to the Dunn County Treasurer by July 31st** (installment amounts are noted on the tax bill).

Delinquent and Postponed Taxes:

All delinquent and postponed real property taxes **MUST** be paid to the County.

Method of Payment when paying tax bills for municipalities listed above:

- *Checks to the County should be made payable to: **Dunn County Treasurer***
- *Payments in Person:* Payments that are hand delivered must be made to the proper treasurer by the due date.
- *Payments by mail:* Payments that are mailed **MUST** be **postmarked on the 31st AND received no later than 5 business days after the payment due date.** Mail to: Dunn County Treasurer, 3001 US Hwy 12 E, Suite 102A, Menomonie, WI 54751
- *Payments by credit card or e-check:* Online from the County website Home Page, Select Treasurer Page under Departments, Click on Paying Taxes Online, it will send you to our third party which is ACI Payments, Pay Property Taxes Online or call 1-888-272-9829. Parcel number means tax Id number found in the upper right-hand corner of your tax statement. Enter the 19 digit number with no spaces or dashes. There is a fee for this service.

Failure to Pay on Time:

If either installment is late, the TOTAL UNPAID tax is delinquent and subject to interest and penalty at a rate of 1.5% per month retroactive from February until paid in full.
