

**The mission of Dunn County Treatment Court is to empower individuals to establish and maintain recovery while enhancing community safety.**

**What are the benefits of the program?**

Treatment Court can provide a treatment alternative rather than a lengthy jail or prison sentence. It will assist with establishing a healthy lifestyle and developing a positive support network. Treatment Court works with individuals to improve mental health, coping skills and develop recovery tools.

**What are the eligibility requirements?**

1. 18+ years old
2. Dunn County resident
3. Felony charges related to drug/alcohol use
4. High Risk on COMPAS assessment
5. Moderate-Severe Substance Use Disorder

**Interested in joining Treatment Court?**

Individuals interested in Treatment Court can be referred through the District Attorney’s Office, Defense Attorneys, Probation & Parole Agents, Human Services, or Law Enforcement. Upon referral, individuals will meet with Treatment Court staff to determine eligibility.

*Please allow 30 days from time of referral to sentencing date.*
